

## 2. Project Management and Organization

## 2.1 Corporate Organization and Responsibilities

Northwest Innovations Works Kalama LLC has two owners: Pan-Pacific Energy Corp., a Delaware corporation ("PPE"), which holds an 80% membership interest, and a staff holding vehicle, NIW SHV, Kalama, LŁC, a Washington limited liability company ("SHV"), which holds a 20% membership interest.

PPE is majority owned by Shanghai Bi Ke Clean Energy Technology Co., Ltd., a Chinese company ("CECC"), which is in the process of acquiring all PPE shares held by the minority owner. The shareholders of CECC are the Chinese Academy of Sciences Holdings, Co., Ltd. (45%), Double Green Bridge Hong Kong Limited (44%), and Johnson Matthey Public Limited Company (11%).


SHV is majority owned by PPE. The other SHV owners are employees and consultants who hold profit interests that are subject to vesting and forfeiture restrictions. PPE intends to restructure the SHV equity arrangements and may acquire the outstanding profit interests as part of the restructuring.
